**Announcement of Explicit the Authorization of Pre-shipment Inspection Organizations
for Import Waste Raw Materials and Their Respective Operation Scope and Area**

In order to further strengthen the pre-shipment inspection work of import waste raw materials to the Mainland of China, the General Administration of Quality Supervision, Inspection and Quarantine of People's Republic of China (hereinafter referred as AQSIQ), based on Article 22 of 《 Regulations for the Implementation of the Law of the Peoples Republic of China on Import and Export Commodity Inspection 》 and Article 6 & 12 of 《Accreditation Management Method of Authorized Pre-shipment Inspection Organizations for Import Waste Raw Materials (on trial)》 , officially announced the Operation scope and area of Authorized Pre-shipment Inspection Organizations for Import Waste Raw Materials (hereinafter referred as Authorized Pre-shipment Inspection Organizations) as follows:

1. AQSIQ has specified the operation Scope and Area for Authorized Pre-shipment Inspection Organization in conducting their pre-shipment inspection for waste material importing into China (See Appendix 1). All authorized pre-shipment Inspection Organization shall base on their operation scope and area when carrying out their related pre-shipment inspections.
2. From September 1st, 2007, if the waste material are loaded or shipped from one of the 39 named countries and regions (hereinafter referred as “Named Countries and Regions”, see Appendix 2), the overseas supplier enterprise shall apply for pre-shipment inspection with the local Authorized Pre-shipment Inspection Organization where the material are being loaded or shipped. Waste raw materials without undergoing Pre-shipment Inspection and obtaining the Pre-shipment Certification are not allowed to enter into the Mainland of China.

Overseas supplier enterprise can apply for pre-shipment inspection online by accessing

the “Electronic Management System for Pre-shipment Inspection of Recycling Scraps to China” (web: psi.cnca.cn). Online User ID and Password for login into the system can be obtained by submitting request to the Chief Supervisor of AQSIQ, the same channel how they obtained their License of Registration for Overseas Supplier Enterprise of Imported Scrap Materials.

3. In case the loading or shipping place is not under the Named Countries and Regions, the overseas supplier enterprise can apply for pre-shipment inspection with the closest Authorized Pre-shipment Inspection Organization by providing necessary inspection conditions. If pre-shipment inspection cannot be implemented due to limitation in inspection conditions, the overseas supplier enterprise can deliver the goods to destination port of the Mainland of China and the Consignee can apply for arrival inspection with The China Inspection & Quarantine organizations (abbreviated as CIQ) at Port of Entry. The CIQ at Port of Entry shall perform 100% Inspection on the above-mentioned waste raw materials for each lot.
4. The Loading Place mentioned in this announcement refers to the place where the waste raw materials are being loaded into container, as bulk goods into vessel, truck or train carriages.

The Shipping Place mentioned in this announcement refers to the originated loading port or site where the waste raw materials are directly (Combined Transportation Included) delivered to the Mainland of China.

The 100% Inspection mentioned in this announcement refers to either inspection done by unloading materials from each container, truck and train carriage which contains the waste import materials or arrival inspection. Waste raw materials delivered as bulk goods in vessel holds shall pass through arrival inspection.
